By entering and allowing your vehicle to remain in this campground, you agree to the following conditions and those included in relevant campground policies. If you do not accept these terms and conditions, you must immediately remove your vehicle from the campground.

Sites cannot be reserved, including by way of personal items (e.g. tents, chairs, signage, etc.) being left in the area for the intended purpose of camping there at a later time.

All persons camping in the area must, in addition to complying with the above conditions, comply with all applicable laws and Council by-laws including (but not limited to) activities in relation to the lighting of fires and interference with vegetation. Penalties for non-compliance apply.

Fires are not permitted on a total fire ban day or during the declared fire danger season.

Pets are permitted but must not cause disturbance to others. If pets are causing a disturbance for other campers, you may be required to leave the campground.

The peaceful enjoyment of the campground and its facilities by all campers is important to Council.

## TERMS AND CONDITIONS

The District Council of Loxton Waikerie will not, under any circumstances, be liable or responsible for any damage or loss; and all injury, loss or damage to person or property is at the risk of the persons entering and/or leaving their vehicles in this area.

People entering this area agree to indemnify Council against any loss or damage arising out of negligence or breach of these terms and conditions.

No other person or organisation other than Council has the authority to vary, waive or excuse compliance with any of the terms and conditions.

- Maximum stay: 7 nights within a 21 day period
- Sites are provided on a first come, first served basis
- Camping sites may not be reserved in any way
- Campers are asked to ensure the site is left clean, tidy and in a sanitary condition for future visitors • All signage must be obeyed.
